Sealed Bids for the Water Service Line Materials Verification project will be received by the City of Hudson, Michigan, at the 121 North Church Street, Hudson, Michigan 49247, until (time due) 2:00 p.m., local time, on December 13, 2022, at which time they will be publicly opened and read.

In general, the work consists of verification of approximately 187 water service line materials on both sides of the curb stop by hydroexcavation.

The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid, and Labor and Material Bond in the amount of 50% of the Bid.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 90 days after the actual opening thereof.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid which is deemed most favorable to the Owner.
