To be submitted in a sealed envelope, marked “**BID FOR (City of Lima, Ohio; Wastewater Treatment Plant – Diesel Fuel Tank Replacement, Contract 57)**” to the Mayor of the City of Lima, Ohio, attention Purchasing Department of the City of Lima, Ohio; Municipal Center, 50 Town Square, Lima, Ohio 45801, before 10:00 a.m., Lima Time, on Tuesday December 12, 2023. At which time, they will be publicly opened and read. Outside of an envelope not being properly marked, may result in Bid not being received, by the Purchasing Department, before the deadline, and could result in Bid being disqualified. Please complete all forms included in the Bid Specifications. Forms not being filled out correctly and/or completely may result in Bid being disqualified.

In general, the work consists of removal of an existing underground fuel storage tank, day tanks and associated piping and electrical; installation of a new above ground fuel storage tank, day tanks, equipment foundation and associated piping, electrical and controls.

Bids must be submitted on the forms bound herein, must contain the names of every person or company interested therein, and shall be accompanied by either a Bid Guaranty and Contract Bond in the amount of 100% of the amount bid with satisfactory corporate surety, or by a certified check on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid.

The Contractor shall be required to pay not less than the prevailing wage rates established by the Ohio Bureau of Employment Services, Wage and Hour Division.
