Sealed Bids for Biosolids Improvements, will be received by the, at the City of Angola, at the Board of Public Works and Safety c/o Clerk Treasurer at 210 N. Public Square, Angola, IN 46703 until 6:30 PM, local time, on July 15, 2024, at which time they will be publicly opened and read.

In general, the work consists of construction of a steel building for maintenance storage, demolition and replacement of the adjacent paved areas. The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid.

The Contractor shall be required to pay not less than the prevailing wage rates established by the State of Indiana.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 30 days after the actual opening thereof.
