Sealed Bids for City of Van Wert, Water Treatment Plant Spray Aeration will be received by the City of Van Wert, at 515 East Main Street, Van Wert, Ohio 45891, until 11:00 a.m., local time, on ~~September 10, 2026~~ September 17, 2026 (**Addendum 1, Issued August 12, 2026**), at which time they will be publicly opened and read.

In general, the work consists of TTHM reduction equipment installed in an existing buried clearwell including, four mixers, four spray aerators, four ventilation blowers and the concrete structure to support the equipment; replacement of four slide gates at water supply reservoirs.

The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid.

The Contractor shall be required to pay not less than the prevailing wage rates established by the Ohio Bureau of Employment Services, Wage and Hour Division.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 90 days after the actual opening thereof.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid which is deemed most favorable to the Owner.
