ADVERTISEMENT FOR BIDS

Sealed Bids for WWTP Improvements will be received by the Village of Oak, at 146 Church St., P.O. Box 232, until 2 pm, local time, on ~~September 24, 2026~~ November 5, 2026 (**Addendum 1, Issued 09/04/2026**) at which time they will be publicly opened and read.

In general, the work consists of construction of a head works treatment process including screening and raw sewage pumping; plant electrical and controls in a stand-alone building; grit removal, new Orbal oxidation ditch, two new secondary clarifiers, new ultraviolet disinfection and meter flume with outfall to the Portage River. Replace the sludge dewatering press and support equipment in an existing building. The improvements will also include upgrade of support services such as heating, ventilation, plumbing, electrical, instrumentation and controls and SCADA. Portions of the existing plant are planned to be demolished as an alternate the work.

The Contractor shall be required to pay not less than the prevailing wage rates established by U.S. Department of Labor, Wage and Hour Division for the State of Ohio.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 90 days after the actual opening thereof.
